

**WHEATLANDS METROPOLITAN DISTRICT
RESOLUTION TO AMEND 2026 BUDGET**

WHEREAS, the Board of Directors of Wheatlands Metropolitan District (the “**District**”) certifies that at a regular meeting of the Board of Directors of the District held August 13, 2026, a public hearing was held regarding the 2026 amended budget, and, subsequent thereto, the following Resolution was adopted by affirmative vote of a majority of the Board of Directors:

WHEREAS, the Board of Directors of the District adopted a budget and appropriated funds for fiscal year 2026 as follows:

General Fund	\$2,561,430
Operations Fund	\$307,800
Parks Fund	\$2,852,193
Recreation Center Fund	\$1,051,651

and;

WHEREAS, the necessity has arisen for additional expenditures by the District due to additional costs which could not have been reasonably anticipated at the time of adoption of the budget, requiring the expenditure of funds in excess of those appropriated for fiscal year 2026; and

WHEREAS, funds are available for such expenditure.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the District does hereby amend the adopted budget for fiscal year 2026 as follows:

General Fund	\$2,662,350
Operations Fund	\$326,600
Parks Fund	\$2,953,114
Recreation Center Fund	\$1,337,219

BE IT FURTHER RESOLVED that such sums are hereby appropriated from the revenues of the District to the funds named above for the purpose stated, and that any ending fund balances shall be reserved for purposes of complying with Article X, Section 20 of the Colorado Constitution.
